PRIVACY POLICY

Vaughan Chamber of Commerce is committed to protecting the privacy of the personal information that is shared with us by employees, members, volunteers, donors and others who may be involved in our activities or on our website. Vaughan Chamber of Commerce personnel are authorized to access personal information based only on their need to deal with the information for the reason(s) for which it was obtained.
